This year, Higgins secured payment on a \$13.5 million verdict for the family of a 40-year-old mother who died from an infection. Also this year, partner Krysia J. Syska negotiated a \$5 million settlement on behalf of a baby with neurological impairment from a birth injury, and Thompson obtained a \$1.7 million settlement for the family of a 24-year-old woman who fell to her instant death from an unsafe structure at a public event.

The firm's newest additions to the litigation team, Nicholas D. Cappiello, and Benjamin R. Novotny, named to *Rising Stars*, are clearly following in their mentors' footsteps, having secured settlements in excess of \$2 million in the past year alone.

While the accolades are many and certainly appreciated, the firm's true legacy is the clients it serves, the burdens it has eased and the lives it has transformed.
